How do I register on the portal if I am a first time user?	<ul> <li>Click on <a href="https://www.armshareschemes.co.za">https://www.armshareschemes.co.za</a> or copy this link into your web browser.</li> <li>Choose <a href="https://www.armshareschemes.co.za">Register</a> and enter your ARM email address. Follow the instructions.</li> </ul>
How do I log into the portal after I have registered?	<ul> <li>Click on <a href="https://www.armshareschemes.co.za">https://www.armshareschemes.co.za</a> or copy this link to your web browser.</li> <li>Log in using your ARM e-mail address as the user name.</li> <li>The portal will send a <i>One Time Pin (OTP)</i> to your registered mobile phone every time you log in.</li> </ul>
May I use my mobile device to connect to the portal?	<ul> <li>The portal is optimised for laptops and desktop web browsers. Some mobile devices may work.</li> <li>It is not advised to only rely on your mobile device to connect to Singular at this stage.</li> </ul>
Can someone help me to log in or use the portal?	<ul> <li>Contact ARM IT on 011 779 1112 or <a href="mailto:ithelpdesk@arm.co.za">ithelpdesk@arm.co.za</a></li> <li>Support service available 24/7; rotational phone service after hours.</li> </ul>
What do I do if I forget my password?	<ul> <li>Choose Login and I forgot my password.</li> <li>Enter your ID number and ARM e-mail address.</li> <li>Follow the instructions from the e-mail you will receive shortly.</li> </ul>
How do I change my password?	<ul> <li>Choose <i>My Profile</i> and enter the old password and the new password in repeating fields.</li> <li>Log in using your new password.</li> </ul>
